

CALLAWAY SUMMER STYLE SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A purchase or payment will not improve your chances of winning. The Callaway Summer Style Sweepstakes (the "Sweepstakes") begins at 12:00:01 a.m. Eastern Time ("ET") on July 18, 2018 and ends at 11:59:59 p.m. ET on August 4, 2018 (the "Entry Period"), when all entries must be received. Eastern Time shall control for all purposes of this Sweepstakes. Sponsor's computer is the official time-keeping device for the Sweepstakes. The Sweepstakes is governed by these Official Rules and is subject to all applicable U.S. federal, state and local laws. Void where prohibited.

1. Eligibility. The Sweepstakes is open only to legal residents of the fifty (50) United States, District of Columbia, or Puerto Rico, who are 18 years of age or older at the time of entry. Proof of residency and age may be required. Employees of Perry Ellis International, Inc., Callaway, and each of their respective subsidiaries, divisions, affiliates, and advertising or promotional agencies, and the immediate family and household members of such individuals, are not eligible to enter or win. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, regardless of where they live.
